***Note Regarding Releases:**

June 2015-The United States Supreme Court decision in Gobeille v. Liberty Mutual (March 1, 2016) has negatively impacted the submission of commercial claims data to MHDO. Several of our largest payers (who represent about 80% of our commercial claims data) notified the MHDO following the decision that they were suspending all data submissions to the MHDO until they worked out the technical and legal issues raised as a result of the decision.

In response to these concerns the MHDO sent a communication to the payers stating that the MHDO will suspend the enforcement of data submission requirements under Rule Chapter 243, Uniform Reporting System for Health Care Claims Data Sets, for a five month (March – July 2016) period.

We hope after this five month period we will all gain some clarity regarding the direction of claims submissions post Gobeille decision. **During this interim period we will not be releasing updated commercial claims data. The most current commercial claims data available is through December 2015.**

The MHDO is committed and actively working on a solution that will minimize disruption and allow us to maintain a comprehensive claims database. Revisions to Hospital Data Release Dates:

MONAHRQ

03/17/16: ***2012 and 2013 Inpatient & 2012 Outpatient Files** - Refresh files are now available by request.

Hospital Quality Ratings

01/26/16: ***2012 and 2013 Inpatient Patch Files** - In December we reported that the patch files as described in the release notes would be released in February. We are revising that date to March 11, 2016.

01/22/16: ***2015 Q1 & Q2 Inpatient and Outpatient Data Release** - Release date revised to November 2016, so that the entire year of data will be released together.

11/4/15: ***2012 Inpatient and Outpatient Data Release Information** - Inpatient and Outpatient data were previously released (Summer of 2014 and Falls of 2015), but additional data have been received since, and incorporated into the November 2015 release. See the release notes for more details.

11/4/15: ***2013 Outpatient Data Release** - The data is currently undergoing an internal Q.C. process; therefore the release date is TBD.

October 9, 2015 Note: Once we transition to our new hospital data submission system in July 2016, we will be working toward our goal of making inpatient hospital data available 90 days after the close of the submission period (as many of you requested).

Example:

Hospitals are required to submit 2016 Q2 data 90 days after the end of the quarter, approximately September 30th. Our policy will be to make the data available for release 90 days after submitted –in this example by January 1, 2017. The feedback regarding the release of outpatient files was that it is not required as frequently and that annual release would be fine. **We will release the annual outpatient data on the same date that we release Q4 inpatient data of a given year.**
