Annual Reset of Exemption and Profile Level Validation Overrides

Summary

- The data validation override reset will occur on 4/4/23.
- New data validation overrides will need to be requested for 2023 files.

Annual Data Validation Override Reset

Profile and Exemption Resets

- All existing profile and exemption-level data validation overrides will expire as of April 4, 2023. Submissions that occur after this reset (Q1 2023 data or late Q4 2022 data) will be evaluated against all validation rules. New overrides will need to be submitted based on validation results.
- New profile and exemption-level overrides must be requested as needed.



Requirements for Updating Facilities' Users, Contacts, and Summary Information

Annual Updates to Registration due 4/30/23.

Annual Registration Updates

Updates to Registration Information

- All hospital registration information Users and permissions, Contacts, and Summary Information such as facility's Campus, Campus Sub entities (clinics), and Data Streams- needs to be reviewed and updated annually.
- During the month of April 2023 hospitals complete their updates in the Portal.
 - Updates will occur in the Summary, Contacts and Users screens.
- Detailed instructions on what to review and how to make updates will be provided on April 3, 2023.



Data Validation Updates

Summary

- Changes effective 12/14/22.
- Changes effective 4/4/23.

December 2022 Changes

- In order to avoid false failures due to the ongoing addition of new COVID related codes MHDO lowered the threshold for three high impact validation rules.
- The changes went into effect on 12/14/22.
